This course was taught to 100 NSA Security Professionals (ISSM / ISSO), the DoD, Navy, National Nuclear Security Administration, Department of Energy National Labs, and to many other organizations.

**The ITDG provided Expert Guidance to the DoD / ICA's on ITM.** From 2009 to 2011 Mr. Henderson in conjunction with the ITDG, was part of a special group of Counterintelligence and Security professionals from the DoD, ICA's (NCIX-NSCS, NGA, NRO, NSA, CIA) and the FBI that were instrumental in developing what is known as National Insider Threat Policy for the DoD and ICA's. The mission of this group was to enhance security within the DoD and ICA's for detecting and mitigating Insider Threats, and preventing espionage.

**In support of this mission Mr. Henderson was assigned to the DoD Insider Threat Counterintelligence Group (ITCIG) and provided guidance on ITM in the following areas:**

- Assisted the DoD ITCIG in establishing a comprehensive and structured Enterprise ITM Framework (ITMFW), that integrated the security disciplines of Counterintelligence (CI), Security and Information Assurance (IA). The ITMFW defined the baseline activities to be conducted by DoD Combatant Commands, Services and Agencies (CSA's) to support their ITP's.
- Mr. Henderson developed a DoD ITM Inspection Checklist covering CI, Security and IA. This checklist was used to conduct comprehensive audits of DoD organizations for compliance with various DoD directives, instructions, policies.
- Mr. Henderson worked closely with DoD CSA's and provided them guidance and training to assist them with the establishment of an ITP for their organization.
- Mr. Henderson briefed Senior DoD and Intelligence Community leadership on Insider Threats, espionage cases, and emerging trends.
- Mr. Henderson researched, evaluated and recommended various Insider Threat Detection Tools to provide for the identification of malicious network activities or indicators of Insider Threats and Espionage on DoD classified and unclassified networks.

**The ITDG is a pioneer and visionary in the field of ITM.** In 2014 the ITDG was one of the first companies to offer comprehensive ITP Development / Management Training to the U.S. Government and defense contractors, who were required to implement ITP's, based of off National Insider Threat Policy and NISPOM Conforming Change 2 regulations.
